3. HAZARDS IDENTIFICATION:

Highly flammable. Irritating to eyes. Repeated exposure may cause skin dryness or cracking. Vapours may cause drowsiness and dizziness.

4. FIRST AID MEASURES:

GENERAL:

IN ALL CASES OF DOUBT OR WHEN SYMPTOMS PERSIST, ALWAYS SEEK MEDICAL ATTENTION

IN HALATION:

Move affected person to fresh air, If recovery not rapid, seek medical attention. If breathing stops, provide artificial respiration. Keep affected person warm and at rest.

IN G E ST I O N:

Only when conscious, rinse mouth with plenty of water and give plenty of water to drink - (approx 500ml). DO NOT INDUCE VOMITING. In case of spontaneous vomiting, be sure that vomit can freely drain because of danger of suffocation. Keep patient at rest and obtain medical attention.

SKIN:

Remove contaminated clothing. Wash affected area with plenty of soap and water. Obtain medical attention.

EYES:

Rinse immediately with plenty of water for at least 5 minutes while lifting the eye lids. Seek medical attention. Continue to rinse.
